If you are participating via dial-up, you can raise your hand at the appropriate time by pressing *9. When it is your turn, the Executive Director will unmute you, and you will be able to make your comments based on the above time frames. Once your time is up, you will once again be muted and the next person in line will be given their opportunity to speak.
